QUESTIONS AND CLARIFICATIONS

- Q1. Can you confirm where within our submission we should include the tables provided in Appendix C? Can you also confirm that we may create these tables in our own format as long as all information remains unchanged from the tables provided?
- A1. Proponents can create their own tables as long as all information remains identical to the tables provided.
- Q2. Regarding the Proposal Minimum Requirements item 2.3 ("Provide three (3) examples of projects that you and your staff have completed in the past ten (10) years that is similar in scope to this project"), would the City consider allowing ongoing projects or extending the timeframe to 15 years?
- A2. The requirement stands firm at 10 years or less, encompassing ongoing projects. It's essential to emphasize that the evaluation of proponents' scores could be impacted by ongoing projects, as they may not fully reflect the entire lifespan of a project.
- Q3. Can we request a 2 week extension?
- A3. At this point in time, the City will not be extending the Closing Date and Time. Please monitor the City's website for further addenda.
