The Committee considered the following focus question:

• We've outlined a few ways that expanding housing options in the Southwest could contribute to sustainability. Are there other ways?

- The City's institutional memory relative to the public consultations for past Community Planning processes in Coquitlam's southwest, and whether that information was accessed by staff when the SWHR was prepared
- What the City had learned from, and how well had it achieved the goals of, its past community plans applicable to Coquitlam's southwest
- The understanding that the City considers Community Planning documents to be living documents that will evolve over time, according to current needs
- The SWHR's proposal for soft densification within its neighbourhoods
- The belief that the contributions and sustainability facets identified within the City's past community plans relative to Coquitlam's southwest area are important
- The belief that a balance between sustainability and densification of neighbourhoods within southwest Coquitlam is not being achieved
- Concern at the amount of green space and tree cover that has been removed from southwest Coquitlam over time, and the belief that those essential natural assets are what make the community livable

The Chair called for any other speakers and, hearing none, thanked the Planner 3 for the presentation.

The Planner 3 encouraged the Committee to contact him by email and to visit the SWHR website to provide further input.

At the request of the Planner 3, the Committee Clerk undertook to email a copy of the presentation to the members.

- The belief that, in some instances, green roof projects could be preferable to solar powered projects or vice versa, and the need to find the right application to fit the technology

The Chair invited the members to provide input regarding potential work plan topics or items for consideration as part of the draft 2021 Work Plan, and spoke to the need for balance between the suggestions from the Committee and staff's work plan programs for the coming year. The Committee proposed the following items:

- Urban farming and food security, including backyard chickens and beehives
- The establishment of sub-committees to investigate topics, including light and noise pollution
- The City's partnerships and how to better engage the public relative to environmental initiatives
- Residential stormwater management
- Preventing the dumping of pollutants into City watercourses
- Green infrastructure
- Tree clearing/cutting mature trees during development

The Chair thanked the Committee members for their input, noting that additional items could be emailed to the Manager Environment within the next month.

6. SEAC Members' Roundtable/Emerging Issues (Standing Agenda Item)

The Chair invited the Committee members to share items of information and emerging issues from their communities.

In response to a question raised by a Committee member, the Manager Environment spoke to the City's efforts, and those of the BC Conservation Service, to curtail interactions between users of local parks and trails and the bears/bear cubs frequenting and foraging in those areas, and the desire to ensure the safety of both people and wildlife.

In response to a question from a Committee member, the Manager Environment spoke to the ways that illegal spills of deleterious substances into watercourses could be reported to the City and the enforcement challenges that staff sometimes encounter when working to determine where such spills originate.

In response to a follow-up question from a Committee member, "How can we help as a Committee?", the Manager Environment noted that members were welcome to consider the question and share further ideas and proposed items for the draft 2021 Work Plan with staff.

In response to a question from a Committee member regarding the possibility of educating the public about illegal poaching, fishing, and harvesting of natural materials from local forests, the Chair noted that citizens were encouraged to contact Bylaws to ask questions and report illegal activity.

A Committee member shared information regarding the Province's RAPP Line (Report all Poachers and Polluters).

The Manager Environment noted that the poaching of wildlife or overharvesting of fish is Provincially regulated and should also be reported to the Conservation Officer Service.

A Committee member shared that she had made the decision to resign from the Committee and spoke to the enjoyment she had derived from volunteering and expressed appreciation to her fellow Committee members for their camaraderie during her tenure.

The Chair expressed sincere thanks to the current and outgoing Committee members, noting their valuable input, feedback, and volunteerism during the year.
