The Minutes of the Economic Development Advisory Committee Meeting held on Wednesday, March 4, 2020 were approved.

3. QNet Fibre to Business Pilot

The Manager Information and Communications Technology provided introductory comments relative to the QNet strategy to support Coquitlam's businesses.

The Telecom Services Manager provided a presentation entitled "QNet Fibre to the Business Pilot" and referred to slides titled as follows:

The Manager Information and Communications Technology provided a presentation entitled "Free Public Wi-Fi" and referred to slides titled as follows:

- 19 Parks & Civic Facilities with Free Wi-Fi
- Next Steps

Discussion ensued relative to the following:

- The desire to recognize the positive impact of free public Wi-Fi on the community
- The desire to compare the cost of the current and the upgraded park Wi-Fi strategies
- The desire to provide enhanced Wi-Fi availability at a fair cost for local businesses
- The desire to explore the cost effectiveness of free public Wi-Fi
- Concerns with respect to providing fibre to areas not in the current business pilot
- The understanding that QNet was adopted into the Information, Communications and Technology Department and falls under the City of Coquitlam's management
- The details of the business pilot in comparison to similar initiatives of other municipalities
- The desire to reduce capital expenditures and reduce lease rates for local businesses requiring enhanced Wi-Fi availability

- The desire to utilize existing street light infrastructure to reduce costs
- The desire to partner with developers to determine business requirements and measures to reduce the cost of fibre implementation
- The desire to determine the cost of implementation for a new business
- The desire to determine if significant cost saving is sufficient as an incentive for new businesses to locate to Coquitlam
- The desire to determine if a cost reduction is available only to current Coquitlam businesses or if it is also available to businesses who relocate
- The belief that QNet availability is an incentive attract high-tech business ventures to locate to Coquitlam
- Concern with respect to the belief that Coquitlam lacks office space
- The desire to focus on industrial business locations with multiple tenants

- The desire to explore areas of expansion after the pilot period
- The desire to focus on underserviced areas to enhance business capabilities
- The desire to allow areas without access to fibre to have cost effective access

- The impact of COVID-19 on Committee Members
- The desire for alternative action plan initiatives that are informed by community input
- Concern regarding typical work culture transitions into remote work atmospheres
- The belief that the alternative City programming that has been made available to residents has had a positive impact
- The impact of COVID-19 on mental health
- The different work place dynamics adopted during COVID-19
- The desire for satellite office space to entice businesses to locate to Coquitlam
- Concerns related to a possible reduction in the demand for office space with the promotion of remote work
- Concerns related to mental health and isolation when working from home
- Survey results from local Coquitlam businesses with respect to post pandemic business plans
- The distribution of remote work opportunity availability between larger and smaller businesses
- Concerns related to transitioning employees between work and home
- The desire to encourage businesses to reduce commuting by utilizing satellite office space
- The belief that corporate culture and workplace socialization is important
- The desire to facilitate an open forum discussion of the challenges faced during COVID-19 by local business owners
- The desire for an open opportunity to share and engage local businesses on their ideas and solutions during COVID-19
- Concerns with respect to the belief that employees of large corporations prefer to receive CERB payments rather than return to work
