Staff Recommendation:

2. Direct staff to enforce City Noise Bylaw No. 1233, 1982 as written in regard to the hours during which construction noise which disturbs is prohibited. This will discontinue the temporary extension of construction hours until 9pm, Monday to Friday, and until 8pm on Saturday as previously endorsed by Council at the Regular Council meeting on March 30, 2020, which was implemented in response to the COVID-19 pandemic
