10. Report of the Director Development Services – Temporary Use Permit (TUP) at 1150 The High Street – CityState Consulting Group (PROJ 20-135)

Discussion ensued relative to the following:

- Support for the proposed temporary retail garden centre
- The benefits of locating a temporary retail garden centre on this site
- Concerns regarding the proposed use of a generator to provide power for the business
- Whether the applicant would consider displaying public art on the fencing surrounding the centre
- Alternative generator options that could be used to provide power to this site
- Whether the City can regulate the use and noise of generators
- The impact of COVID-19 on residents and the concern that the noise of the generator may impact those who are working from home

The General Manager Planning and Development noted that staff can liaise with the applicant regarding the potential use of alternative generator options to provide power to this site.

The Director Development Services provided information relating to the type and scale of the generator that the applicant proposes to use.

Discussion continued relative to the following:

- The length of the proposed Temporary Use Permit
- The ambient noise of the Town Centre area and possible sound mitigation measures that could be put in place if issues regarding the noise of the generator arise
- The proposed surfacing materials to be used to pave the sidewalk

 The differences between the Temporary Use Permit process and the Public Hearing process and the desire for clarification regarding the changes that can be made to a proposed project throughout the consultation and approval processes

Staff provided information relating to the differences between the Temporary Use Permit process and the Public Hearing process.

The General Manager Engineering and Public Works provided information relating to the proposed surfacing materials to be used to pave the sidewalk.

The Deputy City Manager provided information relating to the changes that can be made to a proposed project throughout the consultation and approval processes.

Discussion ensued relative to the following:

- The desire for members of Council to receive the public consultation letters sent as a part of the Public Hearing notification process
- Clarification regarding the accessibility of the proposed units
- Support for the proposed unit mix
- Support for the proposed child care centre and the role of the City in facilitating the development and provision of child care
- The desire for information relating to the floor plans for the proposed development
- Clarification regarding the proposed location for waste and recycling collection

The Director Development Services noted that staff will provide the floor plans in the Public Hearing Brief.

- An easement and Section 219 Restrictive Covenant for shared access of the drive aisle and loading spaces between the townhouse residential lot and assembly child care lot;
- ii. Section 219 Restrictive Covenant prohibiting occupancy until a postclearing and post-construction report from a Qualified Environmental Professional (QEP) is received that evaluates the trees along the new forest edge for safety prior to occupancy; and
- iii. Such other Land Title Office registrable agreements as may be required by the City.
