A Regular Council Meeting for the City of Coquitlam convened in the Council Chambers of City Hall, 3000 Guildford Way, Coquitlam, BC on Monday, April 6, 2020 at 7:00 p.m. All members of Council were present. Members of staff present were the City Manager, Deputy City Manager, Fire Chief, General Manager Finance, Technology and Police Services, General Manager Civic Lands and Facilities, General Manager Planning and Development, General Manager Parks, Recreation and Culture Services, Director Legal and Bylaw Enforcement, Director Development Services, Manager Economic Development, Manager Design and Construction, City Clerk and Legislative Services Clerk.

3. Report of the Director Development Services – Zoning Amendment Bylaw No. 5040, 2020 for Portions of 3553, 3557 and 3563 Victoria Drive (PROJ 19-069)

      - b. a 4.5 m (14.8 ft) wide pedestrian SRW for a future walkway to be constructed with future Lot 8; and
      - c. a 5.0 m (16.4 ft) wide SRW and Section 219 Restrictive Covenant for the MUP under the BC Hydro Right-of-Way (ROW).

ii. Such other Land Title Office registrable agreements as may be required by the City.

- 2. Authorize staff to enter a sub-regional Public Works Mutual Aid Agreement with the Cities of Port Moody and Port Coquitlam and the Villages of Anmore and Belcarra and potentially Metro Vancouver on such terms and conditions as the General Manager Engineering and Public Works deems necessary or advisable;
- 3. Authorize staff to execute an extension of the 1999 Mutual Aid Agreement developed by REAC when appropriate; and
- 4. Pursuant to Section 13 of the *Community Charter*, SBC 2003, C26, consent to the Villages of Anmore and Belcarra providing mutual aid services in Coquitlam if required as contemplated under Ministerial Order MO84.
