Questions & Clarifications

Q1) Does Fortis BC require a permit for this work adjacent to their infrastructure?

A1) Yes a Fortis BC permit is required. Refer to Supplementary Contract Specifications, Section 00 72 43S, Contract Specific Notations – Clause 1.02 – Outside Agency Approval.

The Contractor is responsible for obtaining any required approvals and to comply with the outside agency requirements. Fortis BC requirements may include temporary structural support drawings for their review and approval, for segments of gas lines that are planned to be suspended for any length of time, within the excavation. These drawings are to be prepared by the Contractor's Structural Engineer.

Payment for this work will be treated as incidental to payment for work described in other Sections.

Q2) Will the City consider another extension to the Tender closing date?

A2) At this point, the City will not be extending the Closing Date and Time. The tender closing date remains as April 16th at 2:00 p.m local time.
