Notice of Zoning Amendment Bylaw for First, Second and Third Readings – 573, 601, and 605 Madore Avenue – Bylaw No. 5398, 2025

Notice is hereby given that the City of Coquitlam has received an application to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* relating to the properties located at 573, 601, and 605 Madore Avenue.

The amending Bylaw (No. 5398, 2025) will be presented for first, second and third readings at the Regular Council Meeting on **Monday, July 28, 2025** at 7:00 p.m. in the Council Chambers of City Hall, located at 3000 Guildford Way, Coquitlam, BC.

The intent of Bylaw No. 5398, 2025 is to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* to rezone the subject properties as outlined in black on the map marked "Schedule 'A' to Bylaw No. 5398, 2025" from RS-1 One-Family Residential to RM-2 Three-Storey Medium Density Apartment Residential.

If approved, the application would facilitate the construction of 25 townhouse units within three buildings, consisting of three 3-bedroom units (12%), six 4-bedroom units (24%), and 16 4-bedroom units that include 1-bedroom lock-off units (64%), with a total floor area ratio (FAR) of around 1.4.
