Notice of Zoning Amendment Bylaw for First, Second and Third Readings – 815, 817, 819 and 823 Miller Avenue – Bylaw No. 5461, 2025

Notice is hereby given that the City of Coquitlam has received an application to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* relating to the properties located at 815, 817, 819 and 823 Miller Avenue.

The amending Bylaw (No. 5461, 2025) will be presented for first, second and third readings at the Regular Council Meeting on **Monday, July 28, 2025** at 7:00 p.m. in the Council Chambers of City Hall, located at 3000 Guildford Way, Coquitlam, BC.


The intent of Bylaw No. 5461, 2025 is to amend *City of Coquitlam Zoning Bylaw No. 3000, 1996* to rezone the subject properties as outlined in black on the map marked "Schedule 'A' to Bylaw 5461, 2025" from R-3 Transitional Small-Scale Residential to RM-2 Three Storey Medium Density Apartment Residential.

If approved, the application would facilitate the development of 42 stacked townhouse units within four buildings with underground parking, consisting of 1-bedroom, 1-bedroom plus den, 3-bedroom, 3-bedroom plus den and 4-bedroom unit types.
