Mail Ballot Voting

New for the 2026 General Local Election, all eligible voters can apply to vote by mail.

How to Apply

You must apply for a mail ballot package in order to vote by mail. Find the application at coquitlam.ca/elections or in person at City Hall between September 14 and October 17.

Mail Ballot Dates

September 14	Applications for mail ballots opened
October 5 at 12 p.m.	Deadline to apply for mail ballot package to be sent out by mail
October 5	Mail ballots will be delivered or available for pick-up for approved applicants
October 17 at 8 p.m.	Deadline to receive mail ballots at City Hall to be included in the final ballot count

Elector Registration

If you are not on the Voters List (List of Registered Electors), you may register at the time of voting by making a declaration that you meet the requirements to be registered as set out below:

RESIDENT ELECTORS

To register as a resident elector, you must:

- be 18 years of age or older on General Voting Day, October 17, 2026;
- be a Canadian citizen;
- be a resident of British Columbia for at least 6 months immediately before the day of registration (at the time of voting – April 16, 2026 for General Voting Day);
- be a resident of the City of Coquitlam on the day of registration (at time of voting); and
- not be disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law.

In addition to meeting the requirements above, in order to register at time of voting, **resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

NON-RESIDENT PROPERTY ELECTORS

To register as a non-resident property elector, you must:

- be 18 years of age or older on General Voting Day, October 17, 2026;
- be a Canadian citizen;
- be a resident of British Columbia for at least 6 months immediately before the day of registration (at the time of voting – April 14, 2026 for General Voting Day);
- be a registered owner of real property in the city of Coquitlam for at least 30 days immediately before the day of registration (at the time of voting – September 16, 2026 for General Voting Day);
- not be entitled to register as a resident elector;
- not be disqualified under the *Local Government Act* or any other enactment from voting in an election or assent voting and not otherwise disqualified by law;
- be individuals who are registered owners of the property, either as joint tenants or tenants in common, and not be individuals who are holding the property in trust for a corporation or another trust; and
- have the written consent of the majority of the owners of the property, if there is more than one registered owner of the property, to be the only one of the owners of the property who may register as a non-resident property elector (only one owner of a property may be registered as a non-resident property elector).

In addition to meeting the requirements above, in order to register at time of voting **non-resident property electors** must produce:

1. 2 pieces of identification (at least one with a signature) to prove identity,
2. proof that they are entitled to register in relation to the property, and
3. if there is more than one owner of the property, written consent from the majority of the property owners.

**Non-resident property electors are requested to contact the Election Office for further information on the process for registering as a non-resident property elector.*

TYPES OF DOCUMENTS THAT WILL BE ACCEPTED AS IDENTIFICATION

You must produce at least two (2) documents that provide evidence of your identity and place of residence, at least one (1) of which must contain your signature. The following classes of documents will be accepted:

The above listed identification documents **MUST** be accepted by election officials. An election official may also accept other forms of documents that provide evidence satisfactory to the election official (e.g., a valid, current passport).
