# CoQuitlam

### **Development & Building Activity Snapshot** | T2 2020

As of August 31, 2020

The current global pandemic continues to disrupt various sectors of the economy and it is too early to determine the long-term effects on the housing market and the broader development and construction sector. Following an initial slow-down in the spring, more recent reports indicate that while real estate prices have eased slightly, both sales volume and construction activity appear to be returning to pre-pandemic levels.

#### **Development Activity**

In the second trimester of 2020, 42 new projects were received compared to 35 new projects that were received in T2 2019. This 20% increase in development projects demonstrates the development industry's continued interest in the Coquitlam market. Of note each of these projects are becoming increasing complex. This is evidenced by the increase in the number of dwelling units per application and the number of applications with Housing Agreements for both purpose-built market and below/non-market rental units; master planning development applications for multi-phase high rise, high density projects with complex legal agreements for the timing of amenities and servicing infrastructure; and the densification of established single family neighbourhoods with smaller infill projects based on the Official Community Plan.

<sup>&</sup>lt;sup>1</sup> Projects typically take 12-18 months to achieve their rezoning, development permit, building permit, and servicing approvals plus a further 18-24 months of construction, this means that new units show up 'on the ground' approximately two to three years after Council has approved the project. These numbers include several multi-phase projects that will build out over a number of years and include unit totals that will come on-line over the next decade.

The majority of current development activity is occurring in Southwest Coquitlam (59% of current development applications), primarily in the Burquitlam-Lougheed neighbourhood. However, staff are starting to see more interest in City Centre (37%) as the City Centre Area Plan update moves forward. Table 2: Dwelling Units by Plan Area

The vast majority of current applications are for apartment development (93%) reflecting the urbanized, transit-oriented community we are evolving into. With townhouses at 6%, singlefamily at 0.5% and Housing Choices at 0.5%. The housing choices volume while low has doubled since T3 2019 as applicants are reviewing their project potential given the recent updates to the housing choices program.

Interest in building purpose-built rental and nonmarket rental housing remains high, with many applicants choosing to take advantage of the City's HAS affordable housing incentives. Of current applications, approximately 83% are free-hold or strata units, 14% are purpose-built market rental and 3% are below/non-market rental.

#### **Development Trends**

Over the past two and a half years the number of dwelling units in-process has been steadily increasing which reflects continued applicant interest and the attractive market in Coquitlam. While the absolute number of individual development applications is relatively steady, applications are increasingly complex with an increased number of dwelling units per application.

\*Affordable Home Ownership (AHOP): 109 Affordable Home Ownership units are proposed to be developed in partnership with BC Housing under AHOP. According to the AHOP Program Framework, the affordable home ownership units are created using BC Housing's low interest interim construction financing and equity contributions from the developer or project partner to reduce the cost to eligible purchasers. The difference between sale price and market value is secured through an AHOP mortgage.

\*\*CMHC Rental Construction Financing Initiative (RCFi) applicant projects: if the applicant is successful in qualifying for this CMHC administered program, rental tenure must be guaranteed for a minimum of ten years. Some projects may offer a percentage of units at Below-Market rents, along with other affordability measures. These projects will not be secured by a Housing Agreement with the City of Coquitlam and do not make use of Coquitlam Housing Affordability Strategy incentives. Three projects are proposing a total of 570 units under this initiative. They have been captured here in the Purpose-built Rental category.
