#### **HDPE PIPE SUPPLY BY OWNER**

The Owner has pre-ordered the HDPE pipe only, not including fittings, to address lead time on pipe materials. Once the pipe has arrived at the supplier's yard, the Contractor will assume all responsibility for pipe delivery to site, handling, protecting, fusing, stockpiling and security of the pipe on site, and all other works incidental to pipe supply and installation. The Owner transfers all risk of pipe delivery, scheduling etc. to the Contractor once the Contract between the Contractor and Owner is in in place and the pipe has been delivered to the Suppliers yard.

3. Refer to Supplementary General Conditions (Page SGC 5), Clause 4.11.2 which is reproduced for information:

The contractor's horizontal directional drilling sub-contractor shall only be selected from the below prequalified list.
