OUESTIONS AND CLARIFICATIONS

- Q1) Are there additional partitions opening and closing on the same site?
- A1) For security reasons, further details regarding this subject will be given to the awarded Contractor.
- Q2) Are the elevators monitored by telephone, or by push button tied to main alarm panel?
- A2) All by phone except Maillardville Community Centre. It is tied to main panel.
- Q3) Is the ammonia alarm tied to the main panel or is it a separate system?
- A3) Ammonia alarm is separate from the main panel.
- Q4) Do staff entering a building during closed hours call the monitoring station, and provide:
 - A closing time?
 - A name and code?
- A4) There are two methods depending on the building:
 - I. City staff have a PIN code and deactivate the alarm at the panel upon entering.
 They reactivate the alarm using their PIN at the panel upon leaving.
 - II. The alarm auto-sets nightly at a preset time. It is deactivated upon the first person swiping in using an access card. Should a person need to set the alarm, it can be activated with a double-swipe of an access card.
- Q5) Who is the manufacturer of the alarm equipment currently being used?
- A5) Honeywell and Bosch.

- Q6) Are you transmitting by:
 - Telephone?
 - Telephone & network?
 - Telephone & cell?
 - Network only?
 - Cell only?
- A6) Telephone & cellular.
- Q7) Will the current alarm company release the network and cell equipment, if applicable?
- A7) Yes.
- Q8) Does the City of Coquitlam have the installer codes to the alarm panels?
- A8) No.
- Q9) Can you please confirm the number of monitored systems per site (Indicate if more than 1 intrusion system)?
- A9) Each location listed in the Appendix A -Type of Alarm, Locations and Price Sheet has one system only
