REFUND POLICY:

Where an application for an amendment to the Zoning Bylaw or the OCP Bylaw is withdrawn by the applicant prior to Council's First Reading, or if Council declines the application prior to referral to the Public Hearing, \$1,000.00 of the application fee paid by the applicant shall be refunded within 90 days of receipt of the applicant's written request for such a refund.

Where an application for a Development Permit or Development Variance Permit is withdrawn by an applicant prior to the application being referred to other departments for comment, a refund of the DP and DVP fees paid by the applicant, less 20% shall be provided within 90 days of receipt of the applicants written request for such refund.

Examples of Fee Calculations

Rezoning

$$\text{\$3148.63+ (} \underline{\hspace{2cm}} \text{ X } \underline{\hspace{2cm}} \text{) = } \underline{\hspace{2cm}}$$

(Basic Fee) (Zone Fee) (Area of land rounded up to the nearest 100m² / 100 m²) (Application Fee)

Sample Fee Calculation

Zone: C-4

Land Area: 1609.4 m² = 1700 m²

Zone Fee: \$ 80.61 per 100 m² of land or portion thereof

$$\text{\$3148.63 + (} \underline{\text{\$ 80.61 X 1700 m}^2 \text{/100 m}^2 \text{)} = \underline{\text{\$5669.30}}$$

Subdivision - Fee Simple, Bare Land Strata and Strata Conversion

Note: Fee for three (3) or fewer lots is \$ 3148.63. This calculation is for more than three (3) lots.

$$\text{\$3148.63 + (} \underline{\text{\$115.45 X } \underline{\hspace{2cm}}} \text{) = } \underline{\hspace{2cm}}$$

(Basic Fee) (Lot Fee) (Number of lots beyond 3) (Application Fee)

Sample Fee Calculation

Number of Lots: 7

Lot Fee: \$115.45 for every lot created beyond three (3)

Number of Lots subject to Lot Fee: 7-3 = 4

Subdivision - Phased Strata Title

Gross Floor Area: 1,537 m² (commercial) GFA

Dwelling Units: 150 (residential) units

GFA Fee: \$80.61 per 100 m² of (commercial) GFA, and Unit Fee: \$ 80.61 per (residential) unit.

$$\text{\$3148.63 + (} \underline{\text{\$80.61 X } \underline{1,537 \text{ m}^2 \text{/ 100 m}^2}} \text{) + (} \underline{\text{\$80.61 X } \underline{150}} \text{) = } \underline{\text{\$ 16479.11}}$$

Sample Fee Calculation

Zone: M-1

Gross Floor Area: 425 m²

GFA Fee: \$ 69.86 per 100 m² of GFA

$$\text{\$3148.63 + (} \underline{\text{\$69.86 X } \underline{425 \text{ m}^2 \text{/ 100 m}^2}} \text{) = } \underline{\text{\$3445.54}}$$
